

## OFFICIAL RULES FOR THE “MRN Fan Vote”

### NO PURCHASE NECESSARY TO ENTER OR WIN.

**SWEEPSTAKES PERIOD:** The MRN Fan Vote (“Sweepstakes”) is a series of four (4) voting periods that will run from April 20, 2018 at 9:00 a.m. Eastern Standard Time (“EST”) through May 13, 2018 3:00 a.m. EST, including (1) April 20, 2018 from 9:00 a.m. to April 21, 2018 11:59 p.m. EST (“Voting Period No. 1”); (2) April 28, 2018 from 9:00 a.m. to April 29, 2018 11:59 p.m. EST (“Voting Period No. 2”); (3) May 4, 2018 from 9:00 a.m. to May 6, 2018 11:59 p.m. EST (“Voting Period No. 3”); and (4) May 11, 2018 from 9:00 a.m. to May 13, 2018 3:00 a.m. EST (“Voting Period No. 4”). Administrator will collect all entries for the Sweepstakes and remit such entries to MRN upon the conclusion of each voting period.

**HOW TO ENTER:** During each Voting Period, enter **Online** by visiting [www.mrn.com/vote](http://www.mrn.com/vote) and follow the directions provided to sign up as a registered user using your Facebook credentials or as an unregistered guest. All online entries must be submitted within the Voting Period to be eligible. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address, per household per voting period. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Fraudulent entries will be void.
